Training Description

Much of the healing work for trauma survivors involves interpreting and assigning meaning to the traumatic events in their lives and their experience of these events. Integral to this healing work is recognizing and understanding their unique trauma vulnerabilities; the protective, adaptive responses survivors frequently adopt to keep themselves safe in a world they have come to perceive as inherently threatening. These trauma responses or vulnerabilities take many forms including neuro-biological adaptions, cognitive and emotional effects, and interpersonal and behavioral struggles. Trauma survivors with executive dysfunction present unique challenges in their ability to both express and interpret their trauma vulnerabilities. This training will focus on the unique expression and specific vulnerabilities most often documented in working with this population. It is a population that includes clients with numerous and varied (often co-morbid) challenges including significant trauma histories, developmental disabilities, serious and persistent mental illness, criminal justice involvement, chronic addiction, and traumatic brain injuries.

We will begin by exploring a definition of trauma and trauma vulnerabilities. We will then move to the topic of executive dysfunction, providing both a definition and examples of the varying impacts of executive dysfunction on areas of higher cognitive functioning. The relationship of how trauma vulnerabilities are expressed by individuals with executive dysfunction will be examined with practical, evidence-based recommendations on how to best be responsive when working with this population. Finally, we will explore how best to apply this knowledge; how do we help our clients assign meaning and share their stories to promote improved functioning and healing.

- 4. Understand the unique expression of trauma vulnerabilities for varied individuals with executive dysfunction including individuals with Fetal Alcohol Spectrum Disorder, Autism Spectrum Disorder, developmental disabilities, and traumatic brain injuries
- Examine best practices in being responsive to individuals with executive dysfunction who have also experienced significant trauma
