How Trauma and Other Forms of Adversity Impact Persons on the Autism Spectrum: A Need for a Trauma-Informed Care Response

Training Description

Autism spectrum disorder (ASD) is a neurodevelopmental disorder characterized by social, communication, and behavioral challenges. Although symptoms can vary in type and severity, individuals on this spectrum often struggle in social settings (e.g., communication deficits), exhibit restricted and/or repetitive behaviors or interests, and may not perform well in school, work, or other settings. Individuals with ASD are also at greater risk to experience adverse life experiences such as being bullied, exploited, victimized, and abused (i.e., verbally, physically, or sexually) relative to the general population. Designed for caregivers, family members, and professionals working with individuals on the spectrum, this training highlights the consequences of adverse life experiences (ACEs) on individuals with ASDs and examines how a trauma-informed care response can be beneficial. Other related topics covered include trauma (e.g., complex and developmental trauma), PTSD, and toxic stress as well as three more target areas. First, we will discuss adverse behaviors for individuals with ASD that may stem from experiences of trauma (e.g., sibling abuse, emotional and behavioral dysregulation, substance use, and self-harm). Topics covered will include attachment problems, theory of mind, alexithymia, weak central coherence, rumination, irritability, gullibility, and internalizing and externalizing psychopathology. Second, we will explore the resulting impact on caregivers and the family systems (e.g., parenting and caregiver stress) of those on the spectrum. Third, we will highlight the need for professionals to both (a) understand the challenges faced by individuals on the spectrum and (b) provide trauma informed care to best intervene on behalf of these individuals and their support systems. Empirically based research findings and case study examples will be highlighted throughout this training with practical tips and suggestions.

Training Objectives

- Identify the signs, symptoms, and varying severity levels of autism spectrum disorder
- 2. Explore adverse life experiences (ACEs) including their consequences and red-flag indicators
- 3. Consider the role of ASD in exposure to trauma and other ACEs
- Discuss the implications of ASD and adverse life experiences on screening and interventions
- Review the principles of trauma informed care and the role of the helping professional in relation to individuals with ASD and their support system (e.g., parents, caregivers, and siblings)
- 6. Review empirically-based research findings and relevant case studies
