#### **Training Description**

Fetal Alcohol Spectrum Disorder (FASD) is an umbrella term utilized to reflect the range of manifestations resulting from prenatal exposure to alcohol. FASD is a lifelong disorder that can cause a host of emotional, behavioral, social, and physical health consequences. Research has found that a high percentage of individuals with FASD come into contact with the criminal justice system. As such, it is imperative for professionals working within the criminal justice system to have an understanding of this disorder and learn about what resources, services, and interventions are most appropriate for this highly vulnerable population. One such approach is the Risk-Needs-Responsivity (RNR) model. The RNR model of supervision is widely accepted and embraced within the world of Corrections. The three underlying and interrelated principles of Risk, Need, and Responsivity yield impressive effect sizes around recidivism reduction when implemented with fidelity. Although the Responsivity principle includes language and guidance surrounding the tailoring of services based on specific characteristics and learning styles of the client, little is known as to the relationship of these three principles with criminal justice-involved populations impacted by FASD. As such, the primary focus of this training is to examine the use of the RNR model and its application to the assessment and management of criminal justice-involved populations diagnosed with FASD.

#### **Training Objectives**

1. Define FASD and examine the implications this disorder has on the criminal justice system
2. Provide a foundational outline of the principles of RNR model
3. Examine available research literature pertaining to FASD and the RNR model
4. Learn about key principles underlying the Risk-Need-Responsivity (RNR) model and its application to the assessment and management of criminal justice-involved populations diagnosed with FASD

#### **Presenter Biographies**

**Jerrod Brown, Ph.D.**, is an Assistant Professor for Concordia University, St. Paul, Minnesota and has extensive experience teaching courses at the undergraduate and graduate level. Jerrod has also been employed with Pathways Counseling Center in St. Paul, Minnesota for the past seventeen years. Pathways provides programs and services benefiting individuals impacted by mental illness and addictions. Jerrod is also the founder and CEO of the American Institute for the Advancement of Forensic Studies (AIAFS) and the Editor-in-Chief of Forensic Scholars Today (FST). Jerrod has completed four separate master's degree programs and holds graduate certificates in Autism Spectrum Disorder (ASD), Other Health Disabilities (OHD), and Traumatic-Brain Injuries (TBI). Jerrod is also certified as a Youth Firesetting Prevention/Intervention Specialist, an Anger Resolution Therapist (CART), a Thinking for a Change (T4C) Facilitator, a Fetal Alcohol Spectrum Disorders (FASD) Trainer, an Autism Specialist, and a Mental Health Integrative Medicine Provider (CMHIMP).
